PERSONNEL/OFFICE

- Cory Schmidt, who had been the District Conservationist since 2016, started a new position on January 16th, 2023 with NRCS at the Area Office. Cory is now the Area Resource Conservationist and will serve the 27 field offices that make up the Nebraska NRCS East Area.
- District Conservationist Vacancy (Lincoln Field Office) A job announcement was posted on USAJobs and was open from 1/3/23 1/17/23. Applications are being reviewed.
- Acting District Conservationist (Lincoln Field Office) Tom Cowan (Resource Conservationist in the David City Field Office) was selected as the Acting District Conservationist for a 120-day assignment. Tom began on January 30th, 2023.
- NRCS Soil Conservation Technician Vacancy (Lincoln Field Office) A job announcement was posted on USAJobs and was open from 1/9/23 – 1/23/23. Applications are being reviewed.
- The Lancaster and Cass County Service Centers are under normal operations.

LPSNRD LAND TREATMENT

- Drought conditions are impacting the installation of structural practices across the district. Extra consideration is required prior to construction to make sure there is enough soil moisture to obtain compaction requirements. Staff will be completing evaluations on all fields prior to releasing design paperwork to landowners.
