The Finance and Planning Subcommittee met on Thursday, March 10, 2022 at 5:30 pm both virtually and in the NRD Large Conference Room. Subcommittee members participating virtually included Bob Andersen, Lisa Lewis, Susan Seacrest, Ray Stevens, Vern Barrett, Chelsea Johnson, and Larry Ruth. Directors participating in person at the NRD Office included Don Jacobson. Others participating virtually included Deborah Eagan, Kristin Buntemeyer and myself. Others present included David Potter.

Chair Andersen called the meeting to order and introduced the first agenda item, Planning Retreat Recap and Discussion. A short memo and summary of the retreat was provided and is attached. Staff and the Subcommittee commented on the retreat. I reported that we can now take our ideas on building resilience and begin to incorporate them into our actions and budget requests for FY'23 and beyond.

The next item on the agenda was to review the Budget/LRIP (Long Range Implementation Plan) "Draft" Schedule. I reviewed the proposed timeline for completion of the FY'23 Budget/LRIP and Audit. The schedule is similar to the previous year as our work on the budget begins in April and will be completed in September. I pointed out that two Board Meetings will need to be changed from the usual time/date, the June 14<sup>th</sup> Board Meeting will need to start at 6:00pm to insure that we allow adequate time for public input, and the September 21<sup>st</sup> Board Meeting will need to be moved up one week to meet the budget deadline of September 20<sup>th</sup>.

It was moved by Stevens, seconded by Barrett, and unanimously approved by the Subcommittee to recommend the Board of Directors accept the FY'23 Budget/LRIP Schedule and approve a 6:00pm start time for the June 15th Board Meeting and move the September Board Meeting to 7:00pm on September 14th.

The next item on the agenda was to consider contracting again with HBE for State Budget Form assistance. Buntemeyer/Zillig reported that they appreciated the assistance from HBE and last year everything worked well. I reported that the anticipated cost is estimated to be between \$2,300 and \$3,900 depending on the proposed budget and how that aligns with the state budget lid requirements.

It was moved by Stevens, seconded by Lewis, and unanimously approved by the Subcommittee to recommend the Board of Directors approve the proposed Letter Agreement with HBE for State Budget Form assistance.

There being no further business, the meeting adjourned at 6:00 pm.

# 2022 LPSNRD Directors' Planning Retreat Summary

February 25 – 26, 2022 Lied Conference Center – Nebraska City, Nebraska

The goal of the retreat was "to discuss topics that will assist in long range planning and improvements to LPSNRD programs and projects; to work towards the goal within our HMP of enhancing overall resilience and promoting sustainability; and prepare a list of ideas, projects and programs to make District more resilient and sustainable.

Resilience was defined as "the ability to anticipate, prepare for, and adapt to changing conditions and withstand, respond to and recover rapidly from disruptions." (Executive Order 13653, November 1, 2013, Preparing the United States for the Impacts of Climate Change. 78 FR 66817: 66817 – 66824). Ralph Lassiter, Retreat Facilitator provided an overview of Personal Resilience and its connection to Infrastructure Resilience. A summary document was provided for the Directors' reference.

Work Session 1: In the first series of work sessions, directors identified and ranked (through "dot" voting) the disasters, natural resources and NRD infrastructure that is impacted by disasters.

# Potential Disasters in the District that Trigger the Need for Resilience:

- 1. Flooding (21 votes)
- 2. Water Quality Issues (12)
- 3. Extreme Weather Events (10)
- 4. Drought (8)
- 5. Dam Failure (6)

Following discussion on potential disasters within the District, Paul Zillig presented the attached Drought-Precipitation Index for 1895 – 2021 followed by brainstorming of natural resources that are impacted by disasters, NRD infrastructure impacted by disasters and problems anticipated due to a lack of resilience.

Work Session 2: In the second series of brainstorming exercises, directors identified potential actions to build Resilience in agriculture, natural resources and NRD infrastructure.

# Actions to Build Resilience in Agriculture (not prioritized):

- 1. Follow the NRD's Master Plan
- 2. Keep in touch with the Legislature regarding bills providing funding to update the climate change report
- 3. Provide funding to support land conservation
- 4. Continue to encourage more no-till farming and develop new and improved no-till management options to control "super weeds".
- 5. Information on use of chemicals and their impact on water quality
- 6. Monitor the Ag-Economic environment for actions that increase economic return and decrease the impact on the environment.
- 7. Create a working group to investigate emerging AG issues (i.e., overuse of chemicals, etc.)
- 8. Crop diversification
- 9. Encourage rotational irrigation
- 10. Use of buffer strips. Explore options to increase potential revenue from buffer strips including change in assessment type, their use for hunting, etc.
- 11. Increase funding for "key" programs
- 12. Create simplicity in funding; liability for some conservation programs

# Actions to Build Resilience in Natural Resources (not prioritized):

- 1. Conservation practices
- 2. Public education on resilience issues
- 3. Promote conservation easements
- 4. Increase green space requirements
- 5. Cover crops
- 6. Continue tree programs and support with funding
- 7. Expand the scope of chemicals currently being tested for

# Actions to Build Resilience in NRD Infrastructure (not prioritized):

- 1. Inspect and maintain current infrastructure
- 2. Identify new infrastructure (e.g., Salt Creek Dam)
- 3. Change zoning to prevent construction in flood plains
- 4. Remove properties from flood-prone areas
- 5. Provide public education to vulnerable populations re: infrastructure risks (i.e., flooding) and NRD responsibility to maintain infrastructure
- 6. Design infrastructure for future conditions

Work Session 3: A discussion of the Salt Creek Floodplain Resiliency Study and Other Projects was led by Brian Dunnigan and Paul Zillig, respectively. Other projects included Salt Valley dams, Antelope Valley and Deadmans Run, Perkins County Canal, and STARWARS Lake Development Project. A handout was provided to directors for their reference.

Questions asked during this presentation included:

- Can any of the existing dams be expanded or enlarged?
- What is the quantity of water absorption of these dams?
- Can any of the existing dams be converted to dry dams?
- Can dry dams be combined with cover crops?
- Does the District incentivize conveyance projects out west?
- Are their incentives to maintain the South Platte River which is dry in the summer?

## Additional Actions/Changes to Existing Programs to Build Resilience:

- 1. Silt clean-up
- 2. Provide public education of the benefits of the NRD's programs
- 3. Survey farmers' needs

Work Session 4: The final work session focused on resilience and sustainability with sustainability defined as "the avoidance of the depletion of natural resources in order to maintain an ecological balance."

# **Actions to Enhance Overall Resilience and Promote Sustainability:**

- 1. Share the costs of cover crops with the City of Lincoln
- 2. Strive for a balance in the 3 aspects of sustainability (Social, Economic & Environment)
- 3. Build additional dams which will require "selling" to stakeholders

- 4. Provide public education/outreach
- 5. Continue partnerships re: development
- 6. Move out of an unsustainable situation
- 7. Consider recommendations from the Salt Creek Floodplain Resiliency Study

# **Actions to Help Residents Recover from Disasters:**

- 1. Landscape tree program
- 2. Education programs to increase community buy-in and use of cost sharing projects, including populations that tend to not use such programs (e.g., renters, homeowner associations, etc.)



# DROUGHTPRECIPITATION INDEX 1895-2021

# 1895 - Present (Monthly)

The Standardized Precipitation Index (SPI) is an index to characterize meteorological drought on a range of timescales, ranging from 1 to 72 nonths. The SPI is the number of standard deviations that observed cumulative precipitation deviates from the climatological average. NOAA's National Centers for Environmental Information produce the 9-month SPI values below on a monthly basis, going back to 1895. Learn more.

You have requested that we prepare the financial information and forecasted financial information of the Lower Platte South Natural Resources District (the District), which comprise the 2022-2023 State of Nebraska General Budget Form (the Budget), and the related summary of significant assumptions (forecast), and perform a compilation engagement with respect to the financial information and forecasted financial information. The forecast will not include a summary of significant accounting policies or other required disclosures not related to the significant assumptions. We are pleased to confirm our acceptance and our understanding of this compilation engagement by means of this letter.

# Our Responsibilities

The objective of our engagement is to:

- a. Prepare forecasted financial information in accordance with the format prescribed by the Nebraska Auditor of Public Accounts (APA) contained in the Budget as of June 30, 2023 and 2022, and for the years then ending in accordance with the cash basis of accounting as required by the APA and based on information provided by you; and
- b. Prepare historical financial information in accordance with the format prescribed by the APA contained in the Budget Form of the District as of June 30, 2021, and for the year then ended based on financial statements for the same period that were audited by us; and
- c. Apply accounting and financial reporting expertise to assist you in the presentation of financial information without undertaking to obtain or provide any assurance that there are no material modifications that should be made to the financial information in order for it to be in accordance with the format prescribed by the APA and the cash basis of accounting.

We will conduct our compilation engagement in accordance with Statements on Standards for Accounting and Review Services (SSARSs) promulgated by the Accounting and Review Services Committee of the AICPA and comply with the AICPA's Code of Professional Conduct, including the ethical principles of integrity, objectivity, professional competence, and due care.

We are not required to, and will not, verify the accuracy or completeness of the information you will provide to us for the engagement or otherwise gather evidence for the purpose of expressing an opinion or a conclusion. Accordingly, we will not express an opinion or a conclusion nor provide any assurance on the forecast or financial information.

Our engagement cannot be relied upon to identify or disclose any misstatements in the historical or forecasted financial information, including those caused by fraud or error, or to identify or disclose any wrongdoing within the District or noncompliance with laws and regulations.

#### Your Responsibilities

The engagement to be performed is conducted on the basis that you acknowledge and understand that our role is to prepare historical and forecasted financial information in accordance with the format prescribed by the APA and the cash basis of accounting and assist you in the presentation of the historical and forecasted financial information in accordance with the format prescribed by the APA and the cash basis of accounting. You have the following overall responsibilities that are fundamental to our undertaking the engagement in accordance with SSARSs:

- a. The selection of the format prescribed by the APA and the cash basis of accounting as the financial reporting framework to be applied in the preparation of the historical and forecasted financial information.

The preparation and fair presentation of the historical and forecasted financial information in accordance with the format prescribed by the APA and the cash basis of accounting, and the development of assumptions that reflect your plans and expectations regarding events and circumstances for the forecast period.
- c. The design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the historical and forecasted financial information.
- d. The prevention and detection of fraud.
- e. To ensure that the District complies with the laws and regulations applicable to its activities.
- f. The accuracy and completeness of the records, documents, explanations, and other information, including significant judgments, you provide to us for the compilation engagement.
- g. To provide us with:
  - i. Access to all information of which you are aware is relevant to the preparation and fair presentation of the historical and forecasted financial information, such as records, documentation, and other matters.
  - ii. Additional information that we may request from you for the purpose of the compilation engagement.
  - iii. Unrestricted access to persons within the District of whom we determine it necessary to make inquiries.

You are also responsible for all management decisions and responsibilities and for designating an individual with suitable skills, knowledge, and experience to oversee our preparation of your historical and forecasted financial information. You are responsible for evaluating the adequacy and results of the services performed and accepting responsibility for such services.

#### **Our Report**

As part of our engagement, we will issue a report that will state that we did not audit or review the forecasted financial information and that, accordingly, we do not express an opinion, a conclusion, nor provide any assurance on it. There may be circumstances in which the report differs from the expected form and content.
