Subject:	Minutes for Recreation, Forestry & Wildlife	Subcommittee Meeting	

On Thursday, May 4, 2023, at 5:30 p.m., the Recreation, Forestry and Wildlife subcommittee met in the Large Conference Room. Subcommittee members present; Anthony Schutz – Chair, Gary Hellerich, Don Jacobson, John Yoakum, Christine Lamberty, Stacie Sinclair, and Ray Stevens. Other attendees were Paul Zillig, Ariana Kennedy, and Will Inselman.

The first item on the agenda was a contract amendment with The Flatwater Group for contractual services related to the Little Salt Creek WFPO Plan-Environmental Assessment. This amendment adds \$100,000 to the existing contract for work that has been ongoing for project as The Flatwater Group works through the review process with NRCS. These funds are 100% reimbursed by NRCS. The Flatwater Group will continue to work with NRCS towards submittal and approval of the Plan-EA by April 2024.

It was moved by Yoakum and seconded by Stevens and unanimously approved to recommend the Lower Platte South NRD Board of Directors authorize the General Manager to approve the contract amendment with The Flatwater Group for contractural services related to the the Little Salt Creek WFPO Plan-Environmental Assessment, pending legal counsel review.

Motion Passed: 7-0

Second on the agenda was the review of the proposed FY 2024 actions and budget request. Staff began by covering FY23 accomplishments, provided background on LRIP and budget codes, master plan goals and objectives, and covered the RF&W measurable goals. Staff walked through each section of the proposed budget and fielded questions from Directors. All LRIP materials were provided to the members of the subcommittee but are not included in the minutes. The approved LRIP documents will be provided to the Finance & Planning Subcommittee to be included in the first draft of the FY 2024 LRIP and budget.

It was moved by Stevens and seconded by Hellerich and unanimously approved to submit the Final FY 24 Actions and Budget Requests and the FY 25-28 Actions and proposed Expenditures to the Finance & Planning Subcommittee for inclusion in the first draft of the FY 2024 Budget and LRIP.

Motion Passed: 6-0 (Sinclair Not Present)

RE: Scope of Service Modification for Professional Services for Little Salt Creek Watershed Plan-EA, Lancaster County, Nebraska

Dear Will:

As you know the coordination efforts with our project partner, Natural Resources Conservation Service (NRCS), throughout this effort have been a necessary, ongoing component of the project. This partner coordination effort has been on the administration, field investigation, plan documentation, and plan review level. The Flatwater Group's (TFG) original contract, scope-of-work, schedule, and fee estimate for the project identified several tasks that have either changed in scope and/or been delayed due to unforeseen conditions at the time of contracting in December 2020. These changes have resulted in a significant slide to the original project schedule. Concerns regarding the project schedule were first identified beginning with the August 2021 progress report, while concerns regarding the project budget were first identified beginning with the September 2021 progress report. A chronology of deliverables, project activities and delays is included as an attachment.

Over the course of recent months, we have had informal conversations with you regarding project budget and the need for TFG to request a contract modification for the remaining tasks for the project. TFG has continued to perform the tasks necessary for a successfully coordinated project, including additional meetings, field site visits, documentation preparation and submitting previously prepared documentation to new NRCS personnel. Because the tasks changed, and final plan submittal is soon but yet to be initiated, TFG is submitting this request for scope of service modification to our existing contract with Lower Platte South Natural Resources District.

Specific tasks (contracted and out-of-scope) that have incurred additional time and effort since project inception, or tasks yet to be completed and require additional effort, include the following:

- 1. Addressing review comments by resource agencies following the submittal of the draft plan in June 2021.
- 2. Providing documentation and assistance with the preparation of a biological assessment for the project.
- 3. Providing project site tours, meetings, and ongoing correspondence for new NRCS team members.
- 4. Providing a second submittal of the draft plan to new NRCS team members.
- 5. Coordinating a USACE and NRCS review meeting to determine wetland delineation and permit compliance determination and coordination for a Plan-EA.
- 6. Preparing review comments/responses to second submittal of the draft plan.
- 7. Coordinating APE review as requested by NRCS.

- 8. Preparing additional mapping to include ARA boundaries, wetland limits, and design plans (30%) for each of the proposed projects as requested by NRCS.
- 9. Update construction cost estimates to 2023 dollars and modify economic analysis results tables in Plan-EA and appendices with amended project list.
- 10. Compile project specific technical data in accordance with updated PR&G guidance as requested by NRCS. Present updated data to comply with NRCS design standards.
- 11. Submit final plan to NRCS National office.
- 12. Preparing review comments/responses and final documentation based on NRCS National office review.
- 13. Coordinating public meeting.

TFG's most recent invoice and associated progress report, dated 9 February 2022, brought the billings-to-date for the total project to 99.5% of the contracted amount \$295,110. TFG is requesting a firm fixed price basis modification for **\$100,000** to cover all labor and other direct expenses incurred for the aforementioned scope of services modification and the completion of the project. TFG's work under this modification would be governed by the terms and conditions in the current Service Agreement between TFG and LPSNRD for the Little Salt Creek Watershed Plan-EA. This request would change our firm fixed price contract from **\$295,110** to **\$395,110**.
